Dear Concerned Representatives of the United States Air Force:

As the elected officers of the Eken Park Neighborhood Association, in accordance with our stated purpose (per EPNA By Laws: http://www.ekenpark.org/pdfs/EPNA%20BY-LAWS.pdf), and with the approval of voting members, we hereby submit the following comment regarding the proposed F35A Operational Beddown as it pertains to the 115th Fighter Wing (115 FW) at Dane County Regional Airport, Madison, Wisconsin.

As a neighborhood directly impacted by the proposed beddown, we would ask for a formal rebuttal concerning the following criticisms of the draft EIS prior to the USAF making a final decision on where to locate the F35A's:

- Recognizing that the USAF "evaluation resulted in minimal to no requirement for afterburner use,"
 (Executive Summary of the United States Air Force F-35A Operational Beddown Air National
 Guard Environmental Impact Statement. p15), no substantive assurance has been provided that
 future afterburner use will be maintained at or below the 5% assumption (EIS p15) used to
 determine the 65db line of impact.
- Given that USAF recognizes that even using current assumptions, "There would be significant disproportionate impacts to low-income and minority populations," (EIS. Table ES-2: Summary of Impacts) and given that "areas immediately adjacent to but outside the 65 db contour may experience more significant impacts," and "Nearly every impacted area within the City of Madison belongs to a census tract with rates of persons of color well above the city- and county-wide averages." (F35 EIS Staff Analysis delivered to Mayor Rhodes-Conway on Sept 1-th, 2019.), no substantive justification for the impacts on marginalized urban populations has been provided.
- In light of the recent surge of flooding events in Madison, and given that our neighborhood is
 downstream of Truax Field within the Starkweather Creek watershed, and given the presence of
 known environmental contaminants at the site, including, "including PFAS PRLs [Potential
 Release Locations]." (EIS. Table ES-2: Hazardous Materials and Waste), it is incomprehensible
 for the USAF to conclude, "Impacts relative to hazardous materials and wastes would not be
 significant." (EIS. Table ES-2: Hazardous Materials and Waste).

Specific actions that the USAF could take prior to making a final decision of where to locate the F35As, and which would constitute a meaningful response to the concerns noted above, include:

- Written agreements with the City, County, and State specifically limiting afterburner use to less than 5%.
- A reexamination of the 65db line of impact using assumptions of greater than 5% afterburner use or with the recognition that significant impacts extend beyond the 65db line, and a formal commitment to provide mitigation to all affected households and business.
- Formal public agreements to coordinate with the WDNR and/or the Governor's Task Force on Climate Change (*Executive Order #52*) to reexamine the environmental impacts on the area.
- Providing an articulated argument concerning the USAF's suggestion that Truax Field is the best choice of airfields to place the F35A's, and allowing an appropriate public comment period for consideration of the argument.
